



Editorial

2021 was a year of many challenges. It was a year laid waste by the Covid 19 pandemic during which we tried to overcome exceptional situations and encourage a return to a certain normalcy, especially for children. Unfortunately, as a result of the pandemic, all indicators of child rights are now in the red zone. We are facing a risk of going back on the achievements of the last ten years in terms of assuring the rights of the child. The situation is very worrisome, with an increase in the number of children living in poverty, a decrease in access to education, an unprecedented increase in violence, exploitation and forced marriages of which children and especially girls are the victims. These perspectives are also affected by climate change, of which 2021 provided many examples and impacted again, the most vulnerable.

Thus, throughout the year, Terre des Hommes Suisse has executed concrete action plans to protect children from violence and exploitation and to allow them to continue to go to school in order to build a future for themselves despite the challenging environment. The organization has also encouraged them to lead their own initiatives. As a result, 635,000 people, including 515,000 children and youth (of which 282,500 are girls) have benefited from our actions.

Terre des Hommes Suisse and its 60 partner associations operating on the ground in 10 countries has never served as many beneficiaries (+36%) before this. This shows how strong the need for action is.

2021 was also marked by a renewed environmental commitment by Terre des Hommes Suisse. This effort, which has been a constant for several years now, has now taken on a new dimension with the measurement of our carbon footprints and the continuous identification of measures to be taken to reduce the environmental impact of our actions. This commitment is essential to ensure a healthy and sustainable environment for this generation and the ones to come.

The past year has been replete with meaningful action, as detailed in the following pages. This strong commitment of Terre des Hommes Suisse to the children is made possible, with your unflinching support. Together, we can work towards a world wherein no child is deprived of his rights. We express our heartfelt gratitude to you for matching steps with us and making this journey possible.

Profile

Terre des Hommes Suisse is a human scale, nongovernmental, independent organization and a recognized public utility based in Geneva. It has worked for more than 60 years, in close collaboration with local organizations, for a world of solidarity and sustainability in which children's rights are respected.

Terre des Hommes Suisse is taking concrete action to uphold the rights of the children in the three areas of priority:



Right to free, adequate and quality education.



Right to protection against all forms of violence and exploitation.



Right to participation of children and young people in decisions that affect them,

This work for the promotion and protection of rights is carried out on the basis of two fundamental principles, which characterize the entire action of Terre des Hommes Suisse.

Act here and there

To act in Switzerland and in 9 countries of Latin America, West Africa, the Caribbean, and Asia, in a coherent and integrated manner, drawing on the work carried out in each country to raise awareness, protect, and open up new perspectives of life to children and young people, is one of our guides of action. The interdependence of the world and the universality of children's rights imply local action, both here and there.

To support the agents of change

Whenever possible. Terre des Hommes Suisse supports children and young people in the development of their capacity to be agents of change, and to participate actively in the construction, today, of a more sustainable world that is more respectful of children's rights. Supporting children and young people in building a sustainable world that respects children's rights is done by mobilizing their families and their communities and by supporting the commitment of civil society around the world. Thus, here and there, the teams act on a daily basis to allow children and young people to be aware of their rights, of sustainable development, to have access to context-appropriate and quality education, to be protected from all forms of violence and

exploitation, and to be able to fully participate in decisions that concern them.

The distinctive feature of Terre des
Hommes Suisse is to support around
sixty local associations in the 10
countries of intervention. Its mission
is in the long-term and is built on
local communities by focusing on the
strong responsibility of local actors
and youth, a key element for
achieving the Sustainable
Development Goals of the 2030
Agenda.

For several years, in the implementation of its actions in favour of children, Terre des Hommes Suisse has been committed to reducing its carbon footprint so as not to endanger the right to a healthy and sustainable environment for future generations. After having determined our carbon footprint, we define, month after month, in a participatory manner, additional actions to reduce our footprint again and again, here and in our countries of intervention. The commitment to limit the environmental impact through our action of aid is essential and should be a standard shared by all. Without it, we cannot guarantee our commitment to respecting a healthy and sustainable environment as an essential right of children. From this respect arise all other rights.



Key figures

With 22 permanent employees (17 full-time equivalents) in Geneva and 41 internationally, as well as more than 160 volunteers, Terre des Hommes Suisse in 2021 reached out to more than 635,000 direct beneficiaries, including 515,000 children and young people.

Covid-19 - Year 2

The Covid-19 pandemic had a strong impact on the activities of TdH Suisse in 2021. The teams in the field have been adapting to the new situation, in order to provide the best possible support to children and young people, who are still severely affected, directly or indirectly, particularly in terms of access to education and protection against violence. Young people have also demonstrated their capacity to be agents of change by committing themselves, here and there, to raise awareness in their communities and bring concrete solutions at their level.

International Programme

The second year of the pandemic has heightened inequalities and almost nullified respect for children's rights in the 9 countries of action of Terre des Hommes Suisse at the international level. Closure of schools, increased risks of exploitation and dropping out of school, or even increased violence in some countries, have made it necessary to adapt our programs to respond to the needs of the children.

In 2021, the international actions of Terre des Hommes Suisse benefited 545,000 people, including nearly 460,000 children and young people, in response to the indirect consequences of the pandemic on their rights to education, protection and participation. During the school closure, children and teachers were supported to ensure that learning did not stop. Courses online or radio classes in the local language, distribution of homework, individual monitoring and teacher training have been used in South America and India to address such learning gaps and make up for this second school year in whole or in part from a distance. The schools were also supported in preparing for the return to offline by ways of drawing up health protocols, organising remedial classes and offering academic support.

Many children, victims of extreme poverty and deprived of the school canteen facility that used to provide them with the only balanced meal of the day, have been supported along with their families, through our food distribution support. Regular campaigns have been organised to prevent domestic violence, forced marriages and labour exploitation which increased during confinement periods. A weekly follow-up on the families and children, over telephone or during home visits ensured protection of children from these social evils to a large extent.

All the teams and local partners mobilized to ensure the continuation of education from home while protecting children from all forms of violence despite the pandemic.

Support to local organizations committed to helping vulnerable populations

The Terre des Hommes Suisse program is implemented in 9 countries in West Africa, South America, Asia, and the Caribbean, in partnership with 49 local associations for the defence of children's rights. It is this local anchoring with civil society organizations in these countries that adaptation actions in the context of the pandemic have been implemented since March 2020, making it possible to reach the most vulnerable and forgotten populations.

Right to **education**

In the world, 635 million children* were still deprived of education in 2021, due to the closure of schools and learning centers. Terre des Hommes Suisse has nevertheless succeeded in enabling many children to continue their education and thus preventing school dropouts.

Learning even without school!

After two years of school closures in Latin America and India, Terre des Hommes Suisse has continued its commitment, despite the pandemic, to allow all children and young people to have access to education. For the poorest children, without access to the Internet, Terre des Hommes Suisse with support of the ministries set up digital platforms and developed learning content that is broadcast by radio, WhatsApp, videos or Youtube. 347,500 children have benefited from educational support in 2021 and have continued their learning. Distribution of homework, home visits by teachers or tutoring of children by the youth in their respective communities complemented the support children received.

When vegetable gardens and experiments replace books!

Traditionally, in the countries of action of Terre des Hommes Suisse, teaching is a mundane routine. Mostly children have had to listen to teachers for many hours and read books passively from a rote learning perspective. Terre des Hommes Suisse has supported teachers in adopting participatory practices and allowing children to ask questions and seek answers. Above all, teachers are trained to be facilitators in the teaching-learning process. Everywhere in the supported schools, school gardens are used for biology, mathematics and chemistry lessons, while promoting agro-ecological farming techniques in rural areas. In India, an experimental kit is used in tutoring centers for students to perform their own experiments. When consulted at the end of 2021, the children reported that these new techniques are real improvements on the education system of the earlier times and are even helping them achieve better academic results!

School without violence

In West Africa and Haiti, corporal punishment is still very common in schools, frequently practised by teachers. These violations of children's rights lead to demotivation, school dropout and trauma for the children. Through training on children's rights and participatory practices and non-violent methods, teachers are changing their practices. In Mali, 82% of children surveyed said they no longer experienced violence from teachers and felt much happier and more motivated to come to schools.

Access to education tailored to the Covid-19 situation



"I have helped children in my neighbourhood with their homework because they didn't understand the instructions that the teachers were sending them, and some of them didn't have internet."

Outdoor classes to compensate for school closures

In keeping with the containment measures laid down by the Government, while providing school support for children in India, open-air classes were organized under the shade of trees! In these open classrooms, nearly 13,000 children were supported by face-to-face lessons, given by teachers on the different aspects of the national curriculum, in the local language. Safe distancing was maintained and masks were worn and this enabled such "green schools" to continue for several months.

Right to **protection**

As a result of the pandemic in 2021, children faced increased risks of violence and exploitation. Terre des Hommes Suisse has mobilized initiatives to protect 93,300 children (including 49,000 girls) internationally.

Fight against the risks of violence and exploitation of children

Since 2020, the risks of domestic violence, forced marriages and child exploitation have increased in the context of school closure and containment measures in many countries. The worsening insecurity in our countries of operation often threatened by attacks of armed groups, has also increased the risk of children becoming victims of violence, looting, recruitment by militants, etc.

Faced with these situations, Terre des Hommes Suisse continued in 2021 to provide training on the rights of children to more than 50,000 people from various families, teachers and local authorities so that they adopt non-violent behaviour that respects the rights of the child. Groups of villagers or neighbourhoods have even been formed to organize awareness sessions in the communities and identify cases of children at risk or victims of abuse. It is due to their intervention that 8420 children and young people identified as victims of violence in 2021. They were offered psycho-social support linked with judicial and police services, school reintegration, etc.

Children defending their protection!

All over the world, lockdowns and closure of schools, and therefore school canteens, have increased the poverty of families and affected their nutrition. Terre des Hommes Suisse has supported the most vulnerable families with emergency aid adapted to their needs and they have been provided with food aid, household materials, school fees, etc. This has enabled children in South America and India to avoid dropping out of school because they would otherwise have been forced into marriage. Other indirect effects of the pandemic have been identified, notably those related to the increased use of new technologies in the context of digital education platforms: the abuse of children as victims of trafficking networks or child pornography are all new risks that children have to face behind their screens. Terre des Hommes Suisse has developed information sessions for children and their parents particularly around the 'Conectate sin riesgo' campaign in Latin America.

Raising awareness to prevent violence



"Before, I didn't know that violence and risks could also happen within the family, but now I have information about it. I am more aware and more cautious about these paradigms. I have learned to understand the danger posed by family members, even if they are relatives, so that I am well prepared. Now I am aware that I have to inform my mother first if there are any risks or inform the elders and siblings and to raise the alarm if necessary".



Protecting Girls

In view of the increased risk of gender-based violence against girls since the beginning of the pandemic (sexual violence, forced marriages, prostitution networks, etc.), Terre des Hommes Suisse has strengthened its actions to protect them. Some of these include specific school support to help girl students stay in school in West Africa, reinforced follow-up of adolescent girls and their families to ensure a better life and to avoid child marriages. In South America, the campaign "# My Mother's Daughter" was launched in the context of the "Women's Rights" campaign. In South America, the # CremeSiTeLoCuento campaign raised awareness on this issue for 45 days (from the International Day of the Girl on October 11 to the International Day of Non-Violence against Women on November 25).

Right to participation

Despite a context that is not very favourable to the participation of children and young people. Terre des Hommes Suisse has maintained its commitment to allow them to express themselves on issues that concern them, and above all be heard by adults.

Children and youth defenders of their rights for today and tomorrow

In 2021, nearly 35,000 children and youth were mobilized to defend their rights and protect their peers from the violence and various risks they face daily. By carrying out a thousand actions and requests, in Switzerland and internationally, during the course of the year, children and young people have committed themselves to change the behaviour of people around them and improve their own situation.

In addition to improving the protection of their rights and education, children have mobilized themselves on the twin causes of environmental protection and the promotion of a more sustainable development. In Bolivia, child eco-reporters have produced 35 photo and video reports on their environmental rights. The campaign they led to claim their right to live in a healthy environment has led to reforestation and waste reduction actions.

Adults are finally convinced!

Everywhere, Terre des Hommes Suisse works with parents, teachers, local authorities, and community members to inform them about the rights of the child so that there is greater awareness and respect. This has also led them to take cognizance of the importance of the right to participation, which is often ignored or misunderstood.

In West Africa, children's clubs or school parliaments have been created in schools and communities. They are to be consulted and are expected to make recommendations. Teachers and family members who were not in favour of children's participation in the classroom have now embraced these approaches. In Mali, a parent said, "At first we didn't agree, we didn't understand, but with time we saw that there are many advantages to involving youth in decisions that concern them, and they are much more motivated in the activities they do." The response of the adults to this initiative has been quite heartening. They have begun to respect the rights of the child. Post the sensitization sessions and dialogue with their children, they have understood the negative impact of domestic violence or forced marriages on adolescent girls.

The commitment of communities to better protect children



"Earlier, many women beat their children. The sensitization sessions and training of parents have helped reduce these practices. We have all been informed and trained on children's rights, including teachers, so that none of us can violate these rights. We must all keep our word and respect our commitment".

Education for children's rights and sustainable development in Switzerland

Acquiring early citizenship skills related to cohesive co-existence and having respect for oneself, for others and for the planet, help children make correct choices and commit themselves to their rights.

A diversified educational offer

For more than 30 years, Terre des Hommes Suisse has been offering children throughout Switzerland, a catalog of activities that arouse their curiosity about themes close to their daily lives and encourage their participation through active teaching methods. The child, if he wishes, can thus act concretely here and now to build a sustainable and united world.

In 2021, the 'Walk of Hope' was organized for children in Haiti, Nearly 29,000 students between the ages of 4 and 13 received educational activities in environmental protection and mobilized Haitian children to prevent the risks of natural disasters.

Nearly 900 students in Vaud and Geneva are involved in 'Robin des Watts', an energy solidarity program conducted in partnership with the Terragir Association, with a new focus on the climate this year.

The Terre des Hommes Education program has expanded with more than 4600 students, sensitized on the rights of the child and sustainable development in 6 Swiss cantons and a new animation on education and protection of children in Haiti was created, based on an escape game to make learning fun.

The communities remain very interested in collaborating with Terre des Hommes Suisse in order to mobilize students in concrete projects, such as the responsible consumption of cell phones or sustainable food, based on local and seasonal products or energy saving.

On the occasion of the International Day of Children's Rights on November 20. specific pedagogical material on the theme of the right to leisure has been produced and is accessible online in Switzerland in three languages. This project was in partnership with Terre des Hommes, Schweiz, Integras and the Foundation Kinderdorf Pestalozzi and has already reached more than 18,000 children!

Children and youth stand up for their rights

2900 children and youth were mobilized for the defense of children's rights in actions such as the Walk of Hope (in digital format), volunteering and collection of used phones. There are 980 children and youth ambassadors for children's rights who work tirelessly in their schools or in their environment (see page 16). For Terre des Hommes Suisse, it is essential to create spaces in which children can make their voices heard and show their solidarity.

Companies are also mobilizing for the Rights of the Child



The first edition of the Corporate Walk of Hope was organized to mobilize economic resources for the rights of the child. It brought together more than 700 employees from 25 companies who walked nearly 110.000 kms from October 17 to November 20.

Robin des Watts: a new focus on climate change

In 2021, the climatic variation of the 'Robin des Watts' solidarity energy program was launched, in partnership with Terragir, The concept is based on 'think global and act local', 200 students aged 10 to 12 from Thônex, from ten classes in five schools got to know about the community in India that benefits from the project. Throughout the school year, the students are trained and made aware of the different types of climate and the impacts of climate change. An action plan involving the planting of thousands of trees in the communities in 2022 is put in place by the students of Thônex, in order to act on climate change mitigation and adaptation.

At the same time, the community is financing a solidarity project to support the action of 600 children in India who are in turn mobilizing themselves to improve their living conditions and combat climate change. They will plant trees and create vegetable gardens in their villages in order to achieve their goal.

Children and youth actors of change here and there

The commitment of children and young people is at the heart of the work of Terre des Hommes Suisse, both internationally and in Switzerland. Young people were strongly mobilised during the months of the pandemic, and the first Children's Conference in French-speaking Switzerland enabled children from all walks of life to make their voices heard by politicians.

Children's Conference in French-speaking Switzerland: Children's civic participation in Switzerland

The first Children's Conference in French-speaking Switzerland was organised by Terre des Hommes Suisse and the SNYC (Swiss Council on Youth Activities) with the aim of having children, express their views on the implementation of their rights.

Supervised and sensitised by young people, children from participating classes and structures in the cantons of Geneva and Valais chose to reflect on the rights of special protection and equality; identity; participation and living as a family. They elected their representatives to the conference.

12 recommendations were defined and presented by the children on 20 November, International Children's Rights Day. The same was presented before several federal and local politicians, as well as the UN Committee on the Rights of the Child.

A network of young ambassadors for children's rights

The International Youth Council, created in 2018, brought together 21 young people aged 15 to 25 from 7 countries, all leaders of children's rights within their community. The aim is to share experiences and practices, to raise awareness of common issues and to train in project management and digital communication, while mounting campaigns to make children's voices heard on their rights. This year, acting as representatives of their countries, the young people participated in consultations on the worst forms of labour, as part of an NGO alliance.

In Switzerland, the network of students has grown into an association within the University of Geneva. The organisation of the Wehope Sports and Music Festival at the Bains des Pâquis, was in favour of children's rights in Geneva.

The young people also organised a debate on the right to education at the University and to raise awareness among a hundred secondary school students in Geneva as part of 'Step into Action', an initiative by young people for young people. They also created a series of podcasts on their commitment.

A healthy environment: a burning priority for children and young people!

In 2021, children and young people around the world have been particularly focused on promoting and respecting their right to a clean, healthy and sustainable environment. In Latin America, many young people participated in the international #MyPlanetMyRights campaign to have this right recognised at the United Nations and the Committee on the Rights of the Child. As a result of this global commitment, a General Comment to the Convention on the Rights of the Child is being drafted. In Bolivia, some 50 children and teenagers have donned their ecological reporting hats and produced photo reports to identify good and bad environmental practices in their territory, either to highlight and replicate them, or to expose them and bring about change. In India, over 1000 children and teenagers celebrated Environment Week in June. They made paintings, planted trees and conducted a webinar on ecosystem restoration.

This right is considered a prerequisite for their physical and mental health, as well as for the realization of other rights.

In 2021, TdH Suisse spent 8.5 million francs (+13% v/s 2020) on its activities in Switzerland and internationally to defend children's rights.

Our work in 10 countries has benefited 635,000 people (+27%), including 515,000 children and young people (+36%). This increase reflects the intensification of our actions with the most vulnerable population specially those at risk of violence or dropping out of school. For the second year running, our key event, the 30th Walk of Hope, had to be cancelled and replaced by the digital walk. Fortunately, all the awareness-raising activities among the school children in Geneva were carried out in compliance with health safety conditions.

After a reduction of 1 million francs in financial resources in 2020, TdH Suisse was able to begin the remobilisation of resources necessary for its actions. We have thus solicited the support from companies in Geneva and made a special effort to launch a campaign to mobilise new donors by presenting our work directly on the streets. All these initiatives will enable us to ensure the sustainability of our actions, despite the year 2021 which closes with a loss of nearly 70,000 francs.

More than 77% of the funds raised were used for the implementation of our programmes. This ratio will quickly return to above 80%, as it has been in the past years. This is essential in a context where children's rights have

Financial **report**

Annex to the annual accounts 2021

Principles for the preparation and valuation of accounts

The financial statements are prepared in accordance with Swiss GAAP FER (core FER and FER 21), the Swiss Code of Obligations, the regulations of the ZEWO Foundation and the Association's Articles of Association. The annual accounts give a true and fair view of the assets, financial situation and results.

The financial year covers the period from 1 January to 31 December 2021. The accounts are drawn up in Swiss francs. During the year, transactions in foreign currencies are converted into CHF at the exchange rate valid at the time of the transaction. At the end of the year assets or liabilities in foreign currencies are converted into CHF at the exchange rate on 31 December.

Comments on the balance sheet

Cash and cash equivalents

Cash and cash equivalents include cash balances, postal accounts and bank current accounts. These cash and cash equivalents are valued at their nominal value.

Securities

Securities are held as a cash reserve. They are cash bonds and are valued at their historical value. Terre des Hommes. Switzerland favours ethical investments.

Receivables

The receivables include the balance of the occupational benefits and withholding tax to be recovered. The valuation is made at nominal value.

Stocks of goods

In this account we have grouped the annual sale of handkerchiefs.

Accruals and deferred income

This account contains prepaid benefits and accrued income.

Tangible fixed assets

For years, no tangible assets have been capitalised. Apart from the computer equipment, the tangible assets are few and old. They were either received free of charge or directly recognised in operating expenses.

Accruals and deferred income

This account includes expenses recognised in the current financial year, but which will not be paid until 2022.

Capital of restricted funds

Fund capital comprises restricted income and donations used for a clearly defined and limited purpose, which is generally spread over several years.

All available thematic funds were used in the year 2021, so that the balance of these "thematic" funds is zero as of 31.12.2021.

Association capital

The capital of the association comprises free capital which can be used for the statutory purpose of Terre des Hommes Suisse, to protect itself against risks.

Restricted funds

The balance of the restricted funds is explained in the table of changes in capital. Details of these changes are available at the headquarters in a double-entry table, which gives the changes on a project-by-project basis.

Segregation of costs

The allocation of costs is in accordance with the ZEWO method: fundraising and general publicity costs as well as administrative costs are calculated and indicated according to the ZEWO methodology.

As regards the creation and publication of the Terre des Hommes Suisse newspaper, the distribution of costs is as follows: 50% of the costs for fundraising and 50% of the costs for the

INFORMATION division, in the programmes in Switzerland.

Volunteering

For many years, Terre des Hommes Suisse has been able to count on the commitment of some 700 volunteers. However, in 2021, due to the Covid-19 pandemic, we could only call on 165 regular and occasional volunteers. As for the nine members of the Committee. they provided almost 500 hours of work.

In total, these volunteers put in 4000 hours of work in the project groups, communication, and administration and for our various events.

In total, the services of all the volunteers for the year 2021 represent a sum of CHF 120,000.

Compensation of the governing

The members of the Board do not receive any compensation for their work.

In accordance with ARR21, we do not disclose the remuneration of the management, as only one person is involved.

As statutory auditors, we have audited the financial statements (balance sheet. income statement and notes) of Terre des Hommes Suisse (Section Romande), Geneva, for the year ending 31 December

The preparation of the annual accounts is the responsibility of the Board, whereas our responsibility is to express an opinion on these accounts. We confirm that we meet the legal requirements on licensing and independence.

Our audit was conducted in accordance with the Swiss Auditing Standard on Limited Auditing. This standard requires that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement. This standard requires that the audit be planned and performed to obtain reasonable assurance about whether the financial statements are free from material misstatement.

A limited audit mainly includes interviews, analytical testing and appropriate detailed examinations of documents available in the audited organisation. It does not include audits of business processes and the internal control system, interviews and other audit procedures designed to detect

During our audit, we did not come across any elements that would allow us to conclude that the annual accounts, which show a balance sheet of CHF 4.187.792.98 and a deficit of CHF 69,486.22, do not give a true and fair view of the assets, liabilities, 1500 financial position and results of operations in accordance with Swiss GAAP and are not in compliance with the law and the

articles of association.

We also ensured that SDC funds were used in accordance with the conditions and annexes of the agreement of 1 January 2021 (Project No.: 7F-10658.01, Contract No. 81067438). We also found that the accounts of local programmes and partners exceeding CHF 100,000 were audited by local trustees.

Networks and campaigns

The defense of children's rights requires the mobilization of the skills and energies present within national and international networks.

At the international level

Terre des Hommes Suisse has participated in joint actions with other national and international NGOs as well as Ministries in the countries of action, aiming at the protection of children against the risks of school drop-out, violence, forced marriages, exploitation, and malnutrition. For example, in the context of digital access for children in South America deprived of school since March 2020. Terre des Hommes Suisse (in partnership with the international coalition of Joining Forces, which includes Save the Children, World Vision, SOS Children's Village, Plan International, Child Fund and the International Federation Terre des Hommes) has developed information for parents and children on the dangers of Internet use by children. A total of 600,000 people have been informed about the risks that children are facing with the increased use of social networks and computer tools as part of the digital education promoted by governmental platforms.

At the local level

Terre des Hommes Suisse is a member of the Fédération of Cooperation, an essential network of cantonal development cooperation, bringing together some sixty associations, whose dynamism and the quality of work are increasingly recognized. Excellent with the city and canton of Geneva, as well as with the Department of Public Education, they were proactive - be it with the organization of the March of Hope, the Children's Conference or the support to the work of Terre des Hommes Suisse. This network built on a strong local anchorage and at national as well as international levels, allows Terre des Hommes Suisse to reinforce the impact of its action and its partners in the defense of children's rights.

In Switzerland

Terre des Hommes Suisse is active in the Swiss Children's Rights Network, the Agenda 2030 Platform. It contributes to the sharing of knowledge according to the level of education through active participation in the RECI (Swiss Network for Education and International Cooperation), the network of extracurricular actors of Education 21 and the thematic exchanges of the Education Network of the SDC (Swiss Agency for Development and Cooperation). Collaboration continued with the Swiss Council for Youth Activities within the framework of the Children's Conference. A new coalition of NGOs was created to create a pedagogical sheet on the rights of the child, distributed at the national level on the occasion of the International Children's Rights Day on 20th November 2020.

Keeping Children Safe

Terre des Hommes Suisse is implementing a child protection policy that protects children against the dangers of abuse within the framework of its activities. The quality of this protection has been certified by the coalition 'Keeping Children Safe'.
