EDITORIAL

Dear readers,

In 2024, Terre des Hommes Suisse remained faithful to its primary mission: to defend and promote the rights of children, particularly in the most vulnerable contexts. This year also marks the end of our 2021–2024 Action Programme, bringing to a close a cycle rich in significant achievements. Over the past four years, more than one million beneficiaries have been supported by our 54 local partners, 134,000 children have started or returned to school, 65,000 children have been actively involved in our participation mechanisms, and 28,000 children and young people who are victims of discrimination, violence or exploitation have received direct support or referrals to competent services.

In Switzerland, Terre des Hommes Suisse continues to inspire confidence thanks to the excellent work of our teams, including awareness-raising in schools and as part of the March of Hope.

The increasingly complex international context – marked by multiple crises, insecurity, climate change and drastic cuts in funding for international development – reinforces the relevance of our partnership approach with local organisations. This localisation strategy, which is more essential than ever, ensures that our actions are sustainable, relevant and rooted in local realities. In the 10 countries where we are active, our innovative projects have demonstrated the power of an approach centred on the most vulnerable, placing children and young people at the heart of the action and decision-making.

Sustainability, equity, solidarity and commitment remain our core values for guiding our action. In 2025, major challenges still lie ahead. Let's continue together to promote a world where every child can fully realise their rights.

PORTRAIT

Terre des Hommes Suisse has been working for children's rights for 65 years, supporting actions to protect, educate and promote the right of children to enjoy a healthy environment. Based in Geneva and recognised as a public utility, our organisation works with 54 local partners in 10 countries in Africa, Asia and Latin America, as well as in Switzerland.

Terre des Hommes Suisse takes concrete action to ensure respect for the rights of the child in **three priority areas:**



Right to education

Facilitating access to quality education adapted to local needs.



Right to protection

Preventing violence and ensuring children's safety.



Right to a healthy environment and participation

Encouraging children to become agents of change in their environment and communities.

THREE PILLARS OF ACTION FOR A LASTING IMPACT

Our mission is based on three fundamental and complementary pillars: quality education accessible to all, including the most vulnerable; protection against all forms of violence and exploitation; and the active participation of children in the decisions that affect them, particularly with regard to a healthy and sustainable environment.

In 2024, faced with growing challenges such as climate crises, conflicts and persistent inequalities, we have strengthened our integrated approach, which places the rights of the child at the heart of all our actions, while fully incorporating environmental issues. Education for Sustainable Development (ESD) is now a major wide-reaching theme in our programmes, raising children's and young people's awareness of environmental issues while developing their skills to become committed and responsible citizens. This comprehensive approach enables us to support children and young people in building a fairer, more sustainable future, by involving them as real agents of change from today.

LOCAL IMPACT THANKS TO SOLID, SUSTAINABLE PARTNERSHIPS

The particularity of Terre des Hommes Suisse lies in its collaborative approach and its local roots. We work exclusively with our 54 partner organisations in the 9 countries where we operate internationally, prioritizing the capacity building of local players and communities. This strategy guarantees the relevance and sustainability of our actions, while promoting local ownership of projects.

With committed teams in Geneva and in our international organisations, supported by several hundred dedicated volunteers, Terre des Hommes Suisse has reached 457,700 beneficiaries, including 297,700 children and young people in 9 countries of international intervention. In Switzerland, our programmes reached nearly 81,000 people, mainly children and young people.

EDUCATION: ACCESS DESPITE THE CRISES



Faced with the growing challenges in our countries of intervention, Terre des Hommes Suisse is strengthening its commitment to guaranteeing access to and quality of formal and non-formal education for the most vulnerable children. Our actions enable children who do not attend school, or who have dropped out, to gain access to school and prevent them from dropping out, thus protecting them from exploitation, forced labour, early marriage and other forms of violence. In 2024, more than 84,300 marginalised children benefited from these protective educational environments, with the involvement of more than 6,200 teachers and 560 schools around the world. Below are just a few examples of our work.

ACCESS TO QUALITY BASIC EDUCATION

Educational centres to combat exclusion from school

Our learning support centres help the most marginalised children to return to school and prevent them from dropping out. In India, our programme supports around 40 such centres, benefiting more than 6,340 children in 60 villages and 17 urban slums.

Teaching methods tailored to children's needs

Improving the quality of teaching is at the heart of our educational work in all the countries where we operate. In India, for example, 340 teachers have adopted a non-violent, participatory approach that is particularly effective for children from disadvantaged tribal and urban communities, resulting in a 96% pass rate in public examinations.

Raising awareness among families

In many of the countries where we operate, we work with families to raise awareness of the importance of education, particularly in communities where children are often the first generation to attend school. This close work with parents creates an environment conducive to learning and reinforces the sustainability of our educational initiatives.

EDUCATION IN CONFLICT SITUATIONS

Schools as protective spaces in Colombia

In response to the upsurge in gang violence in Colombia, we have consolidated our work with around 30 educational institutions in the southern Córdoba, Valle del Cauca and northern Cauca regions. Our work involves strengthening the schools' ability to manage risks,

provide psychosocial support for pupils and prevent them from dropping out of school.

Support for internally displaced children in the Sahel

In the face of growing insecurity in the Sahel, our accelerated school enrolment programme in Burkina Faso maintains education centres in the affected areas. In Mali, we have adapted our approach to meet the needs of 770 internally displaced children, including more than 430 girls, through remedial education programmes. Rehabilitating infrastructure and equipping host schools with appropriate teaching materials creates the conditions necessary for quality learning, even in the face of adversity.

VOCATIONAL TRAINING AND ECONOMIC INTEGRATION

Customised training pathways

Vocational training constitutes an essential lever for the economic integration of young people into our programmes. In Mali, our actions have been fruitful: 100 young people have created 20 viable small businesses, 200 internally displaced young people from now on practise four different trades, and 100 young female family helpers have formed two trades and today lead activities generating revenue.

Referral and support towards employment

Socio-economic integration initiatives are a strategic response to the challenges of economic vulnerability, going far beyond simple technical training. In Burkina Faso, a number of young people are taking courses in sewing, weaving, two-wheeler mechanics and electricity. In India, we are developing partnerships with vocational training institutions, making it easier for vulnerable young people to be integrated into qualification programmes.

OUR ACTIONS TO PROTECT CHILDREN



In many countries, particularly in conflict zones such as Burkina Faso, Mali, Colombia and Haiti, children continue to face multiple forms of violence and abuse. In 2024, Terre des Hommes Suisse strengthened its interventions to create protective environments and support victims. Our approach is based on prevention, early identification and care. This year, we trained nearly 179,600 children to recognise and react to violent situations, raised awareness of positive practices among more than 86,700 adults, and directly supported nearly 7,450 young victims of discrimination, violence or exploitation.

PREVENTION: CHANGING MINDSETS FOR A SAFER WORLD

At the heart of our prevention strategies is the belief that communities have the power to protect their children. We develop protective environments through children's clubs, schools and other safe spaces. By attending these places, children reduce their exposure to domestic violence, recruitment by armed groups or the risk of early marriage.

An essential dimension of our work is self-protection: we teach children to recognise dangerous situations and activate warning mechanisms. Through age-appropriate training, they learn to protect their physical and emotional integrity, strengthening their resilience in the face of challenges they encounter.

In Burkina Faso, for example, we organise regular forums for dialogue on children's rights, in which over 200 groups of parents took part last year. These meetings enable adults to discover alternatives to violent educational practices. The "Cellules Communautaires de Protection" (Community Protection Units) continue their essential work despite the growing insecurity, raising awareness in communities and alerting them in the event of danger.

In crisis situations, we adapt our action to the emergency. In Haiti, where gang violence has displaced thousands of families, we have trained nearly 300 children in first aid. In Burkina Faso, our "Child-Friendly Spaces" have become places of safety for more than 5,600 displaced children, providing a setting where trauma can be expressed and begin to be dealt with, through games, artistic activities and personalised support.

IDENTIFICATION: SPOT AND ACT BEFORE IT'S TOO LATE

The identification of at-risk situations mainly relies on our local partners, children's clubs and peer groups. The educators make regular home visits, creating an essential bond of trust with vulnerable families.

In India, we have strengthened the capacity of local young leaders to identify risky situations in their communities, particularly in relation to early marriage. These young people become sentinels, able to warn others before rights are violated.

Access to civil status, which is essential for registering for school exams, remains a major challenge for many children. In Senegal, it was the children themselves who led a campaign that resulted in 800 suppletive judgements – a first step towards legal recognition and protection.

CARE: REBUILDING AND LOOKING TO THE FUTURE

When prevention is not enough, we continue to work with the victims. In Senegal, the Eden reception office has identified and taken care of 125 vulnerable children. In Bolivia, our "Mujeres en busca de Justicia" initiative illustrates the importance of a comprehensive approach: it offers social, legal and psychological services to support women and children who are victims of violence. Around 40% of the cases handled (approximately 2,000) have resulted in concrete solutions, such as protection measures, the recovery of children or psychological support.

THE RIGHT OF CHILDREN TO ENJOY A HEALTHY ENVIRONMENT AND TO PARTICIPATE



In 2024, Terre des Hommes Suisse reinforced its actions to support children and young people in their transformation into agents of environmental and social change. Our partners developed 930 spaces for participation and trained nearly 41,550 children on their rights. Thanks to this support, young people have carried out more than 1,000 concrete actions to advance their rights and sustainable development in schools and communities. These initiatives have raised awareness among more than 271,820 people.

CHILDREN'S CLUBS

Terre des Hommes Suisse has set up 550 children's clubs in the countries where it operates. These non-formal education spaces enable children to learn about their rights and environmental protection. In Burkina Faso, for example, 205 children's clubs have become learning spaces where participants develop practical skills in waste management, tree planting and sustainable agriculture. In India, over 200 similar spaces for participation have enabled more than 6,770 children and young people to become involved in concrete sustainable development initiatives.

YOUTH COUNCILS

In the countries where we work, TdH Suisse supports youth councils that coordinate local actions. These structures enable teenagers to develop leadership skills and civic commitment. In Peru, a council made up of 10 teenagers, most of them girls, has taken a significant step forward by representing its peers on the UN Committee on the Rights of the Child, taking a determined stance on environmental issues. These councils also play an essential role in identifying children at risk.

SCHOOL PARLIAMENTS

We actively support children in school parliaments to enable them to participate effectively in the governance of their schools. Through these representative bodies, pupils can voice their concerns, whether that's combating violence in education, improving school infrastructure or access to school.

ENVIRONMENTAL ACTIONS

Our programmes make the most of local knowledge while developing practical skills. In Latin America, school gardens in Bolivia and Peru are transcending their primary function to become educational spaces that also nurture a culture of peace. The Peruvian "Apu como Escuela" initiative has been extended to new districts, transforming sacred mountains into living classrooms where children learn about ecosystems.

COMMUNICATION AND ENVIRONMENTAL ADVOCACY

In our "Eco-Reporters" project, which has taken root in Bolivia, Colombia, Peru and as far afield as India, a number of teenagers have picked up cameras to document the environmental challenges that shape their daily lives. This approach enables them to develop a critical eye, while also raising awareness in their communities and bringing their concerns to the attention of decision-makers.

At the same time, the celebration of the centenary of the "Declaration of Geneva" mobilised more than 3,500 children to rewrite this historic text, incorporating their environmental concerns. This initiative affirms that their right to a healthy environment is fundamental to their development and their participation as citizens.

OUR ACTIONS IN SWITZERLAND

In 2024, our Swiss programme raised awareness of children's rights and sustainable development among more than 31,000 schoolchildren across the country. Our actions mobilised nearly 2,800 children and young people in concrete initiatives, making them true ambassadors of change in their schools and communities.

THE WALK OF HOPE:

OVER 30 YEARS OF COMMITMENT TO SOLIDARITY

The Walk of Hope, TdH Switzerland's flagship event, is the biggest solidarity event involving children in French-speaking Switzerland. Its aim is to raise awareness of children's rights and living conditions in the countries where we work, while mobilising the population in support of international solidarity. In 2024, the 33rd edition focused on Mali, bringing together 2,600 walkers on the quays of Geneva.

In the run-up to the event, intensive awareness-raising work reached nearly 75% of primary school classes in Greater Geneva, enabling more than 30,000 pupils to discover the realities of Malian children. Through educational activities, the pupils were able to understand the challenges faced by people displaced by conflict, and were involved in a wave of solidarity that culminated in the weekend of the Walk.

GIVING CHILDREN A VOICE:

THE CHILDREN'S CONFERENCE

The Children's Conference for French-speaking Switzerland brought together 233 children aged 10 to 12 from 8 schools and 3 extra-curricular groups from all over French-speaking Switzerland at the Théâtre Am Stram Gram. Following preparatory workshops on their rights, a number of delegates elected by their peers took part in a brainstorming camp to develop five projects addressing key issues: children's civic participation, environmental protection and sustainable development, the fight against harassment and violence, the promotion of inclusion and non-discrimination, and children's right to be heard in decisions affecting their health. These themes, identified by the children themselves, reflect their real concerns and their desire to take action for a world that is more respectful of their rights.

These projects were presented to politicians at a "World Café" and then in Bern, at the Federal Palace, where the children discussed with a national councillor the possibilities for putting these projects into practice. The child

delegates also met with municipal and cantonal politicians in their respective regions, bringing their voices and ideas to the local level.

ROBIN DES WATTS: UNDERSTANDING AND ACTING FOR A SUSTAINABLE WORLD

The Robin des Watts programme has mobilised 600 student ambassadors in 10 Swiss schools, who have in turn raised awareness among more than 600 fellow pupils. Thanks to the Colibri project, pupils at the Verney school in Puidoux have implemented three concrete initiatives: the introduction of two plate sizes in the canteen to reduce food waste, raising teachers' awareness of the use of trains for school trips, and the creation of an overflow on the school reserve pond to make life easier for birds.

ACTIVE ADVOCACY IN SWITZERLAND FOR CHILDREN'S RIGHTS AND SUSTAINABLE DEVELOPMENT

Within the framework of its Alliance with "terre des hommes schweiz" in Basel, Terre des Hommes Suisse advocates better implementation of children's rights and the Sustainable Development Goals (SDGs) in Switzerland. Together, the two organisations contribute to the work of the "Agenda 2030 Platform", in particular to its co-presidency, as well as to "Alliance Sud".

In 2024, the Swiss Children's Rights Network, which the Alliance chaired for 4 years, published 39 articles and regular overviews of the parliamentary sessions in Berne, raising awareness of the issues of children's participation in decision-making, violence-free education and the well-being of all children regardless of their status. Thanks to our lobbying work, the realisation of children's rights through the Agenda 2030 goals is now included in the Concluding Observations addressed to Switzerland by the UN Committee on the Rights of the Child. We are continuing to advocate for the right of a child to a healthy and sustainable environment to be incorporated into Swiss public policy.

In 2024, we worked with more than 54 partner organisations in Latin America, Africa, Haiti and India, providing financial and technical support to reinforce their capacity

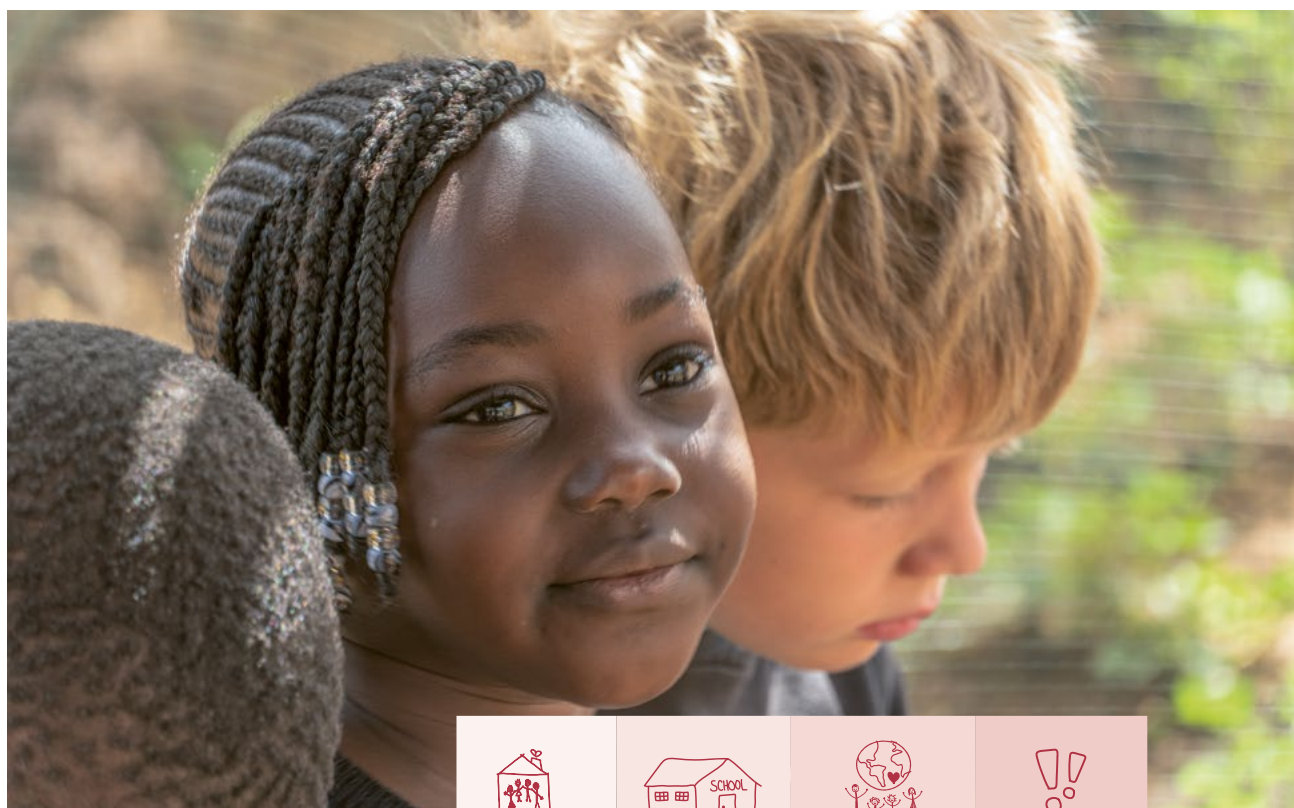

TALKING TO LOCAL COMMUNITIES

In this section, those who are living the realities of our projects take the floor. Children, committed young people and long-standing partners talk in their own words about the obstacles they have encountered and the hopes they hold.

INDIA



JESMIN, A JOURNEY OF DETERMINATION AND EMANCIPATION

In her village in West Bengal, Jesmin defied norms and overcame poverty to become the first girl in her community to attend university. Supported by SMOKUS, a partner of TdH Switzerland, she discovered her rights and developed the confidence to pursue her dreams. Despite her family's financial difficulties, which had forced her brother to drop out of school, Jesmin persevered through the Educational Support Centres, where she excelled academically. Her success at university transformed perceptions in her community. An active member of the Indian Youth Council, she now inspires other young people to believe in their rights and possibilities, proving that girls can also achieve their dreams independently.

INDIA AND THE WORK OF TERRE DES HOMMES SUISSE

In rural India, girls are often deprived of a secondary education, held back by patriarchal norms and economic constraints. Through its partnership with SMOKUS and the Indian Youth Council, Terre des Hommes Suisse promotes gender equality, further education, the empowerment of girls and their right to decide their own future

PERU

HERNÁN, A JOURNEY OF STRENGTH AND HOPE

In the face of devastating family losses and a harrowing pandemic, Hernán, a young Peruvian from Huancarani, found a life-saving refuge in art. His poignant account tells how, thanks to the support of the psychological workshops offered by Terre des Hommes Suisse and its local partner, he transformed his pain into creativity. From isolation and difficulties at school to a new-found confidence, Hernán's journey illustrates the power of youthful resilience when supported by appropriate interventions.

"One ordinary day, the Pacus Centre arrived with Terre des Hommes and they organised a workshop with a psychologist who taught us about emotions and self-esteem. This helped me to overcome all these problems."

PERU AND THE ACTIONS OF TERRE DES HOMMES SUISSE

In the rural Andean areas of Peru, children face persistent poverty, limited access to mental health and unequal education, challenges amplified by the pandemic, the consequences of which are still visible. In response, the "Kuska" programme – which means "Together" in Quechua – developed by Terre des Hommes Suisse with its partner, relies on community educators to promote the well-being and protection of children, by combining psychosocial support, life skills and artistic expression, in an approach that respects local cultures.

SENEGAL

WHEN CHILDREN FROM FORGOTTEN NEIGHBOURHOODS BECOME ACTORS IN THEIR OWN DESTINY

In the heart of the Dakar suburbs, in one of Senegal's most disadvantaged departments, a silent revolution is under way. In Guédiawaye, where the absence of a state school until 2005 is a testament to the challenges faced, children are taking their future into their own hands. Thanks to AJD-PASTEEF's participation circles, they have become investigators and defenders of their rights, revealing that more than 4,500 children had no birth certificate – a major obstacle to their education and their fundamental rights.

THE CRUCIAL ISSUE OF BIRTH REGISTRATION IN WEST AFRICA

In West Africa, the lack of civil registration affects millions of children, depriving them of a legal identity and access to essential services. The statistics are alarming: 30% of children under 5 are unregistered in Senegal, 40% in Mali and more than 20% in certain regions of Burkina Faso. In addition to the 4,500 children without birth certificates identified in Guédiawaye, more than 94 million African children remain "invisible", according to UNICEF.

HIGHLIGHTS OF THE 2024 ACCOUNTS

In 2024, Terre des Hommes Suisse maintained a virtually balanced budget, with a slight deficit of Swiss Francs 29,740.– Its income amounted to almost 9.4 million Swiss Francs, 37% of which came from public contributions and 35% from private donations and legacies. It also strengthened its commitment in the field, increasing spending on its international programme by 7% and on its Swiss programme by 9% compared to 2023. At the same time, the organisation has succeeded in reducing its administrative costs and has remained stable in terms of its investment in resource mobilisation and communication.

Terre des Hommes Suisse continues to diversify its sources of income, developing new collaborations with

institutional donors, foundations and private sector partners in order to secure sustainable funding for its long-term projects.

Your support, whether in the form of regular donations or legacies, remains the cornerstone of our work. In 2024, the generosity of the public enabled us to maintain our impact on children and young people. Every contribution, whatever its size, translates directly into tangible changes in the lives of our beneficiaries.

This report offers you the full transparency that we consider essential to maintaining your trust and continuing our mission to defend the Rights of the Child. We thank you warmly for your invaluable support.

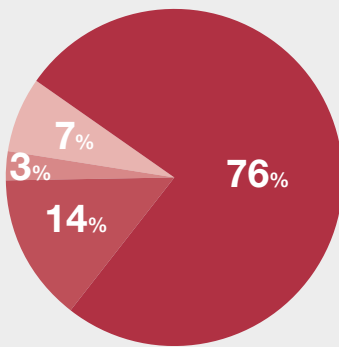

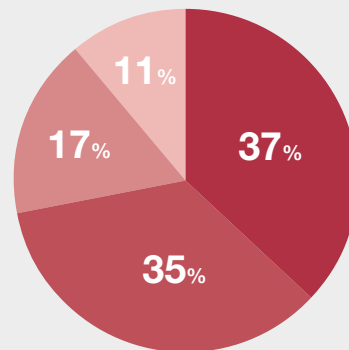
Breakdown of expenditure (%)

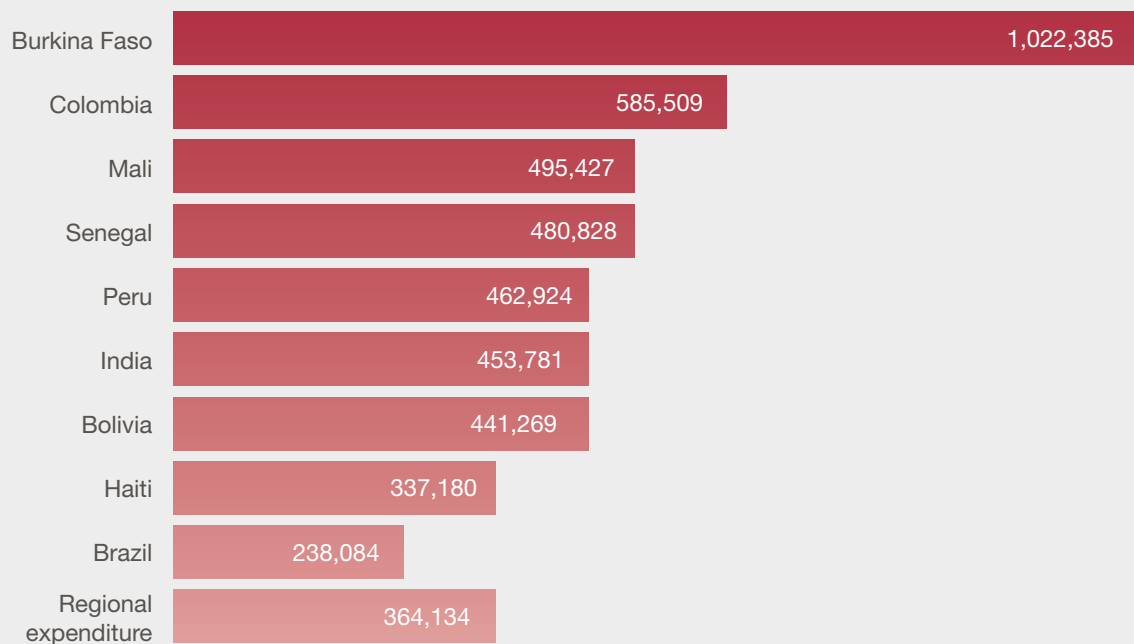


Origin of resources (%)

FINANCIAL REPORT

Notes for the 2024 financial statements

Principles for preparing and valuing the financial statements

The financial statements are drawn up in accordance with Swiss GAAP FER (fundamental FER and FER 21), the Swiss Code of Obligations, the regulations of the ZEWO Foundation and the Association's Articles of Association. The annual financial statements give a true and fair view of the Association's assets, liabilities, financial position and results. The financial year covers the period from 1 January to 31 December 2024. The accounts are drawn up in Swiss Francs. During the year, transactions in foreign currencies are converted into Swiss Francs at the Oanda platform exchange rate. At the end of the year, assets or liabilities in foreign currencies are converted into Swiss Francs at the tax reference exchange rate in Geneva on 31 December 2024.

Comments on the balance sheet

Cash and cash equivalents

Cash and cash equivalents include cash balances, postal accounts and bank current accounts. Cash and cash equivalents are valued at nominal value.

Inventories of goods

This account includes stocks of handkerchiefs held for sale.

Prepayments and accrued income

This account includes prepaid services, accrued income and withholding tax receivable. Prepayments and accrued income are stated at nominal value less any necessary value adjustments.

Property, plant and equipment

The properties initially recorded in the balance sheet at the beginning of 2024 were sold during 2024. At the end of the period, Terre des Hommes Suisse no longer had any property assets. Otherwise, tangible assets are few in number and old. They were either received free of charge or booked directly to operating expenses.

Sundry creditors

Sundry creditors include unbilled supplier debts awaiting payment (Swiss Francs 187,505.-), and key deposits received from the Association's employees (Swiss Francs 1,600.-).

Accruals and deferred income

This account includes expenses recognised in the current financial year but which will not be paid until 2025 (Swiss Francs 109,311.-), as well as income received on the organisation's accounts in 2024 but recognised as revenue in 2025 (Swiss Francs 74,832.-).

Tied fund capital

The capital of restricted funds includes restricted income and donations used for a clearly defined and limited purpose, which is generally spread over several years. See also i) below.

Association capital

The Association Capital includes the General Fund, which can be used for the statutory purposes of Terre des Hommes Suisse, in particular to protect against risks. Its evolution is as follows:

- Balance at 1 January 2024: Swiss Francs 4,037,894.-
- Withdrawal from general fund according to activity account: Swiss Francs 29,740.-
- Balance at 31 December 2024: Swiss Francs 4,008,155.-

Restricted funds

The balance of funds allocated in 2024 (Swiss Francs 2,426.-) is explained in the table of changes in capital (see attached table), and supported by more detailed documents available on request from the Association's registered office.

Separation of costs

The breakdown of costs is in line with the ZEWO method, and includes fundraising, communication and general publicity costs, as well as administrative costs. With regard to the creation and publication of the Terre des Hommes Suisse newspaper, the breakdown of costs is as follows: 50% of costs for obtaining funding and 50% of costs for the Information section of the programme in Switzerland. Similarly, the costs of events open to the general public, such as the March of Hope, are divided 50% for communication and obtaining funding and 50% for the awareness-raising section of the programme in Switzerland.

Other information

Fire insurance – insured value

Fire, natural damage and theft insurance – insured value of furniture and goods: Swiss Francs 90,000. – IT Facilities insurance – refurbishment/new purchase of insured items at replacement value: Swiss Francs 128,000.-

Free of charge

Terre des Hommes Suisse receives donations in kind, in goods or in services. Free of charge City of Geneva: Swiss Francs 51,328.- for the March of Hope.

The Department of Schools and Institutions for Children of the Department of Social Cohesion and Solidarity of the City of Geneva provides Terre des Hommes Suisse with premises in primary schools in the City of Geneva. The rent for the offices and the deposits for the total surface area of 887 square metres loaned are estimated as follows: 887m price range per square metre between Swiss Francs 280.- and Swiss Francs 310.- gives an estimate of free rent included of between Swiss Francs 248,360.- and Swiss Francs 274,970.-

Volunteering

For many years, Terre des Hommes Suisse has been able to count on the commitment of its volunteers. In total, these 339 volunteers put in 4,874 hours of work in the project groups, communications, administration and for our various events in 2024. As for the eight members of the Committee, they put in almost 800 hours of work at 30.- Swiss Francs per hour. In total, the services provided by all the volunteers in 2024 amounted to Swiss Francs 170,220.-

As statutory auditors, we have audited the financial statements (balance sheet, income statement, statement of cash flows, statement of changes in equity and notes) of the Association Terre des Hommes Suisse (Section French-speaking Switzerland) for the year ending 31 December 2024. The 2023 audit was carried out by another auditor).


These financial statements are the responsibility of the Board of Directors. Our responsibility is to express an opinion on these financial statements based on our audit. We confirm that we meet the legal



It does not, however, include audits of business processes and the internal control system, or interviews and other audit procedures designed to detect fraud or other breaches of the law.

Based on our audit, nothing has come to our attention that causes us to believe that the financial statements,

which show a balance sheet of Swiss Francs 5,244,729.17.– and a profit of Swiss Francs -29,740.–, do not give a true and fair view of the assets, liabilities, financial position and profit or loss of the Company in accordance with Swiss GAAP and do not comply with Swiss law and the Company's Articles of Association.

TERRE DES HOMMES SUISSE: AN INTERCONNECTED ACTION NETWORK

To amplify its impact in favour of children's rights, Terre des Hommes Suisse develops strategic partnerships at all levels. These multiple collaborations, both local and international, reinforce our capacity for action and enable us to carry further the voices of the children we support.

In Switzerland and abroad: a networked commitment to amplify our impact

At a national and an international level, Terre des Hommes Suisse is actively involved in several strategic networks. Our participation in the "Swiss Children's Rights Network" and the "Agenda 2030 Platform" strengthens our advocacy for policies that respect fundamental rights. As a member of the Joining Forces international alliance, we join forces with other major organisations to maximise our impact in favour of children's rights.

Aware of the climate emergency and its impact on children's rights, we have joined the Climate Action Accelerator, an initiative that is helping us to reduce our carbon footprint and develop sustainable solutions within our organisation.

In the field of education, we contribute to the sharing of expertise via the "Réseau Suisse Education et Coopération Internationale" (RECI) and "Education 21", while taking part in exchanges within the SDC's "Education Network". Our collaboration with the "Conseil Suisse des Activités de Jeunesse" (CSAJ) has enabled us to organise the Children's Conference, giving a voice to the youngest members of society.

We are also active members of platforms such as the "Switzerland-Haiti Platform" and the "Switzerland-Colombia Platform", which enable us to coordinate our actions with other Swiss players in these countries. As a member of "Alliance Sud", we work for a more coherent and supportive Swiss foreign policy. Our special partnership with Swiss Solidarity supports several of our education and protection projects.

At a more local level, Terre des Hommes Suisse is a member of the "Fédération Genevoise de Coopération" (FGC). We have developed excellent synergies with both the City and Canton of Geneva. These collaborations are key to the organisation of the March of Hope, the Children's Conference and all our work.

Terre des Hommes Suisse within the Terre des Hommes Movement

Terre des Hommes Suisse is a member of the Terre des Hommes Movement, coordinated by the "International Federation of Terre des Hommes" (IFTDH). This federation includes autonomous organisations, such as the Terre des Hommes foundation in Lausanne and terre des hommes schweiz in Basel, which share a common vision for the defence of children's rights.

Since 2019, Terre des Hommes Suisse and terre des hommes schweiz have strengthened their collaboration by creating a formal alliance. We work together, both in the countries where we operate and in Switzerland, to raise public awareness and lobby the authorities on issues relating to development policy and children's rights.

Alongside this alliance, Terre des Hommes Suisse has also developed a close partnership with Terre des Hommes Germany, specifically for our programs in Mali and Burkina Faso.

Ethical commitment and transparency

Terre des Hommes Suisse operates to the highest standards of transparency, quality and protection. The organisation is certified by the Zewo label, which attests to rigorous management of funds, clear communication and real social impact. This recognition strengthens the confidence of donors, partners and the public in the integrity of our action. Terre des Hommes Suisse is also a member of the Keeping Children Safe initiative, an international network of organisations committed to keeping children safe.
